Hawaii Revised Statutes Section §321-375 **Examination, fee required.** States that:

- a) No license shall be issued unless the applicant takes an examination as prescribed by the director and receives a passing score or meets the criteria specified in section 321-374(c). No license shall be issued unless all fees required by the director have been paid.
- b) The State of Hawaii Department of Health does not conduct tattoo artist license Blood Borne Pathogen (BBP) examinations.
- c) The department now contracts with professional testing services to prepare, administer, and grades the examination for blood borne pathogen testing required for licensure as a tattoo artist. For these purposes, the department require applicants to pay **the blood borne pathogen certification examination fee** directly to the testing service. The **tattoo license** fee of \$75 is paid to the Department of Health.

COMPLETE STEPS 1, 2, AND 3**

- b. Application for New Tattoo Artist License
- c. Fee: \$75. Cash or Check. (Check payable to: State of Hawaii)
- d. Tuberculosis and Syphilis Report Form
(Strongly recommend Hepatitis B Vaccine)

Any information or forms missing will be returned to the applicant.

STEP 4: Your license will be mailed to you

- a. Your original TB/Syphilis Report Form will be mailed back to you
- b. Submit a copy of the TB/Syphilis Report Form to the Hawaii State Tattoo Shop where you will be employed.
