AN ORDINANCE DESIGNATING A PORTION OF MAY AVENUE AS REGINALD D. WALKER, SR. AVENUE.

WHEREAS, Reginald DeSoto Walker, Sr., attended Booker T. Washington Middle School and Booker T. Washington High School. He later attended Florida A&M University (where he was one of the "Marching 100") and Savannah State College, where he completed double majors in Music Education and English. He Attended Hampton Institute and later received his Master's degree from Columbia University. He continued his music education at Vandercook School of Music, Catholic University, Hampton University, Norfolk State University and Peabody Conservatory of Music; and

WHEREAS, Reginald DeSoto Walker, Sr. served as Choir Director for Ruffner Junior High School; and, from 1962 to 1989, he was the band director for Booker T. Washington High School, Music Instructor of St. Helena's Elementary School, Roberts Park Elementary School, Tidewater Park Elementary School, and James Monroe Elementary School; and

WHEREAS, Reginald DeSoto Walker, Sr. was a member of the Dukes of Rhythm, Bobbie Robinson Orchestra, Haywood Night

and the Swing Masters, the National Educator's Association,
American Band Director's Association, Virginia Music Educator's
Association, Tidewater Area Musician's Association, Virginia
Band and Orchestra Director's Association, Music Educators
National Association, Musician's Education Conference, American
Federation of Musicians, and Omega Psi Phi Fraternity, Inc.; and

WHEREAS, Reginald DeSoto Walker, Sr. was an organist for several Norfolk churches, including the Queen Street Baptist Church, Jerusalem Baptist Church, and Bethel Baptist Church; and

WHEREAS, Reginald DeSoto Walker, Sr. received numerous awards in recognition of his service to others, including awards from the Center Stage, Inc., Norfolk Public School Board, Queen Street Baptist Church, Bethel Baptist Church, Booker T. Washington High School, the Elementary Resources Teachers Association, the God's Creation Choir, the Marching Booker Alumni Band, and on May 12, 1986, the City of Norfolk proclaimed Reginald DeSoto Walker, Sr. Day; now, therefore,

BE IT ORDAINED by the Council of the City of Norfolk:

Section 1:- That the portion of May Avenue from E. Virginia Beach Boulevard to E. Princess Anne Road is hereby designated as Reginald D. Walker, Sr. Avenue. (See Exhibit A, attached hereto.)

Section 2:- That this ordinance shall be in effect from and after its adoption.
